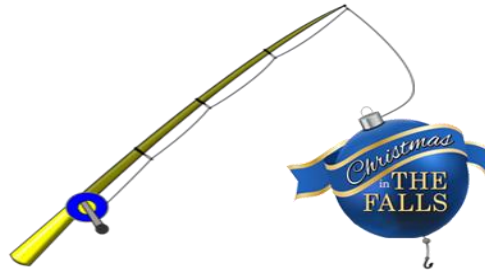

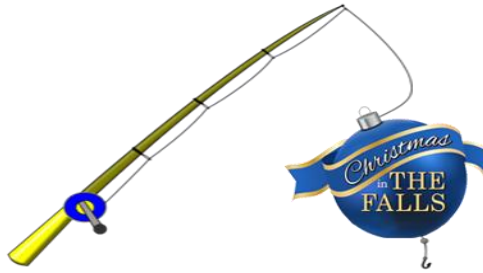

Event Rules & Regulations

Flopeye Fish Festival. All Rights Reserved. Thank you for joining the Christmas in the Falls in supporting the future of Great Falls. Proceeds help benefit the Flopeye Fish Festival and to provide scholarships to local high school students to continue higher education.

To help maintain the facility and in consideration of others, please read the following Event Rules & Regulations designed to help provide you with a safe and enjoyable experience throughout the weekend.

- 1) Vendors
 - a) All vendors must be registered with the Christmas in the Falls in order to participate in the event.
 - b) Vendor spaces are assigned, by first come, first serve basis. All vendor booths must be kept on the chosen space throughout the day and cannot impede another space. Pop-up tents and stakes must be within the marked space. Aisles must be kept open at all times for emergency vehicle access as required by our public safety agencies. Any offenders are subject to removal and expulsion from the event.
 - c) All cars/trucks will not be moved during the festival event.
 - i) Vendors setting up Saturday morning, no vehicle operation allowed on the festival grounds after **10:30am**.
- 2) Medical Emergencies
 - a) Dial 911 for any medical emergency or incident. For minor injuries, visit our on-site medical tent located near the stage.
- 3) GENERAL REGULATIONS & CONDITIONS
 - a) Safety is the primary concern when dealing with a large crowd and motor vehicle movement. Anyone operating a motor vehicle in an unsafe way will be removed and expelled from the event.
 - b) No motor vehicles are allowed on the festival grounds during the event. Please use parking area provided.
 - c) No alcohol or firearms allowed on the premises.
 - d) No camp fires or grills are permitted on the show grounds.
 - e) Loud music, radios, stereos, TVs, loudspeakers, etc. ARE NOT permitted on the festival grounds.
 - f) Generators causing excessive fumes and/or noise are not allowed. Generators must be vented to a point at least eight feet above the ground and located such that fumes will not funnel into surrounding areas occupied by other participants.
 - g) Trash containers are provided on the show grounds. PLEASE use them to keep your space and surrounding area clean. As you exit the event, do not leave trash on your space.
 - h) Golf carts cannot be operated by anyone who does not have a valid driver's license.
 - i) The Flopeye Fish Festival reserves the right to reject car show registrations or vendor applications on the basis of not fitting into the scope of the event or unsatisfactory personal conduct or behavior prior to or during the event.
 - j) The Flopeye Fish Festival is a fundraising event. All proceeds are deemed donations to this fundraiser and are, therefore, nonrefundable.
